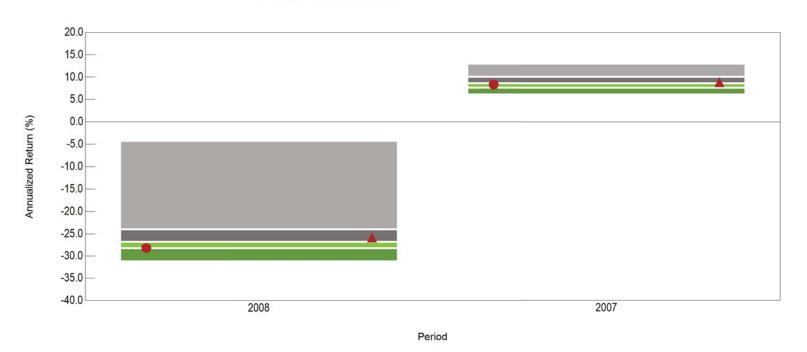

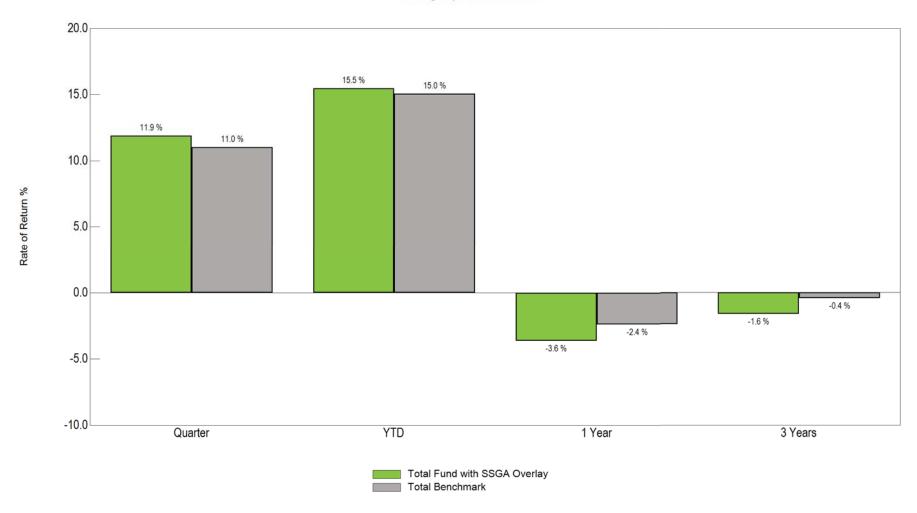

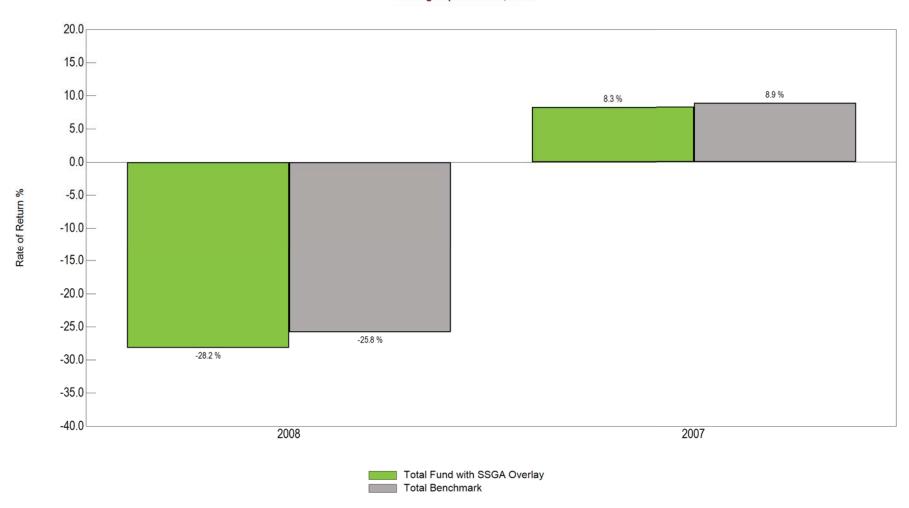

Fund Return vs. Benchmark Portfolio Return Ending September 30, 2009

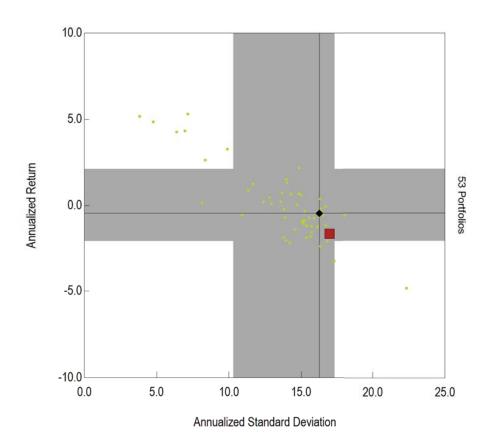

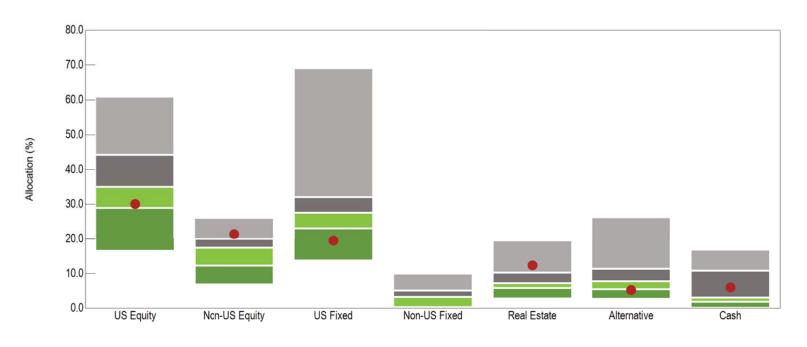


Annualized Return vs. Annualized Standard Deviation 3 Years Ending September 30, 2009

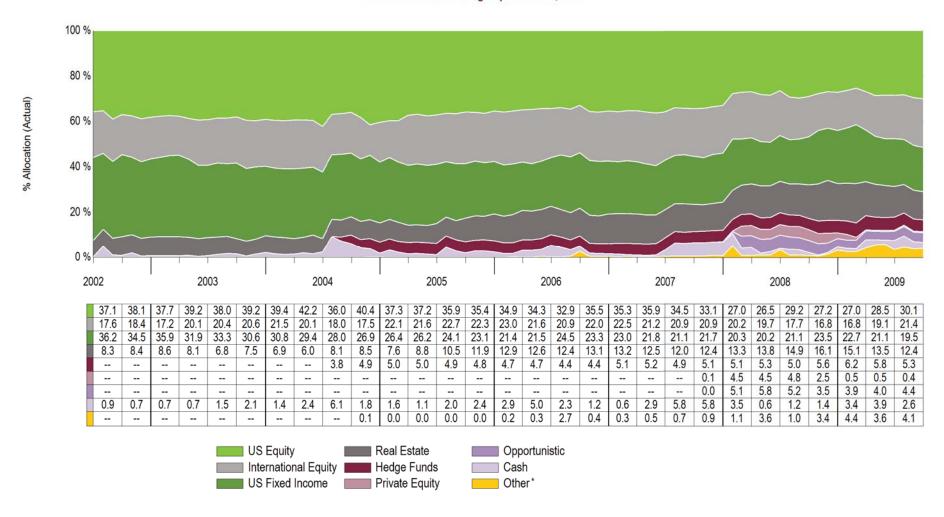

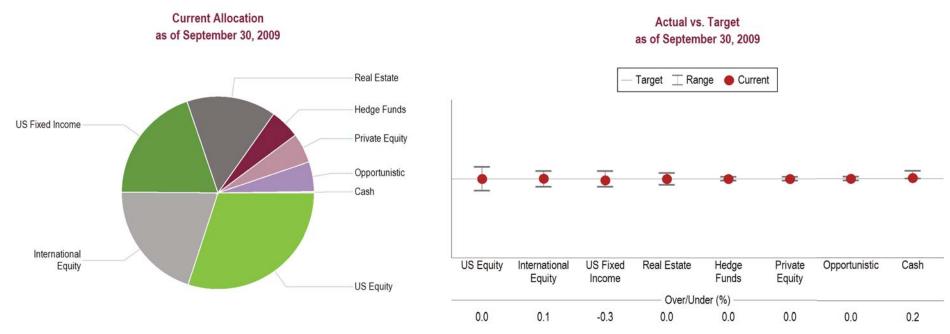
